

Summary of School Board activity

The board was unable to contribute at the time of publication.

School Context

Palmerston District Primary School is a growing P-6 school in the Gungahlin Network and was opened in 1995. There are 736 students currently enrolled. The school is a harmonious mixture of families from different backgrounds and cultures. We have welcomed the residents of Crace to the school in recent years. We are comprised of 6 preschool classes, 36 mainstream classes, 2 Learning Support Units. There are 92 staff members, including 6 administration staff, 1.6 Building Support Officers (BSOs), 15 Learning Support Assistants (LSAs) and 12 part-time teaching staff. Currently we are awaiting the installation of new relocatable learning units. These are expected to be completed by the beginning of term 4 2022.

We are an established school that sets high expectations for all and upholds positive values that reflect our community. We model our school values of Palmerston PRIDE - Participation, Respect, Integrity, Determination, Empathy. Our Positive Behaviour for Learning (PBL) framework explicitly helps us to acknowledge our students for being a safe, respectful learner. Parents and teachers work together to be role models for our community through being lifelong learners and creating a harmonious and inclusive environment that supports respect for all.

Palmerston District Primary School strives to provide for all our students. We are a school on the move. We provide a band program with two bands, lunchtime clubs, student leadership opportunities, additional external and internal academic and wellbeing opportunities and we often host sporting clinics. We provide a written report to families in terms 2 & 4 with an offer of parent/teacher interviews in terms 2. We offer Japanese as our language for years 3-6 and provide music as a specialist subject. Our library is open each day. A Before and After School Care program is on site for years Preschool to 6.

Palmerston District Primary School has a preschool for up to 100 preschool children. Our statement of philosophy is: At Palmerston Preschool we believe in the importance of developing strong family and community connections. These connections should ensure that students feel as though they belong in our wider school community. We embrace the Early Years Learning Framework 'Belonging, Being and Becoming'. We aim to extend and enrich children's learning while in our care.

As a whole school community, we facilitate an environment which fosters contributions by students, teachers and parents. The Palmerston District Primary School community lives by its motto of: Together, we learn from each other.

Student attendance

Staff Information

Teacher qualifications

All teachers at this school meet the professional requirements for teaching in an ACT public school. The ACT Teacher Quality Institute (TQI) specifies two main types of provision for teachers at different stages of their career, these are detailed below.

- Full registration is for teachers with experience working in a registered school in Australia or New Zealand who have been assessed as meeting the Proficient level of the Australian Professional Standards for Teachers.
- Provisional registration is for newly qualified teachers or teachers who do not have recent experience teaching in a school in Australia and New Zealand. Many teachers moving to Australia from another country apply for Provisional registration.

Workforce composition

Workforce composition for the current reporting period is provided in the following table. The data is taken from the school's verified August staffing report. For reporting purposes, it incorporates all school staff including preschools, staff absent for a period of less than four consecutive weeks and staff replacing staff absent for more than four consecutive weeks. It does not include casuals and staff absent for a period of four consecutive weeks or longer.

The Education Directorate is required to report Aboriginal and Torres Strait Islander staff figures. As of June of the reporting period, 135 Aboriginal and/or Torres Strait Islander staff members were employed across the Directorate.

School Review and Development

The ACT Education Directorate's Strategic Plan 2018-2021 provides the framework and strategic direction for School Improvement Plans (formerly School Strategic Plans). This is supported by the school performance and accountability framework 'People, Practice and Performance: School

Improvement in Canberra Public Schools, A Framework for Performance and Accountability'. Annually, system and school level data are used alongside the National School Improvement Tool to support targeted school improvement, high standards in student learning, innovation and best practice in ACT public schools.

Our school is scheduled for review in Term Two 2022.

School Satisfaction

Schools use a range evidence to gain an understanding of the satisfaction levels of their parents and carers, staff and students. Annually in August/ September ACT schools undertake a survey to gain an understanding of school satisfaction at that time. This information is collected from staff, parents and from 2020 students from year 4 and above (previously year 5 and above) through an online survey.

Overall Satisfaction

In this period of reporting, 78.6% of parents and carers, 94.5% of staff, and 64.0% of students at this school indicated they were satisfied with the education provided by the school.

Included in the survey were 8 staff, 9 parent, and 10 student items which are described as the national opinion items. These items were approved by the then Standing Council on School Education and Early Childhood (SCSEEC) for use from 2015. The following tables show the percentage of parents and carers, students and staff who agreed with each of the national opinion items at this school.

Due to the impacts of the COVID-19 pandemic, the survey was taken in November, rather than in August as has been done in previous years. This was just after the majority of students and staff returned to school-based learning after a period of around 3 months of remote learning. A number of questions were removed from previous years' to shorten the time required by community members to complete the survey.

A total of 55 staff responded to the survey. Please note that not all responders answered every question.

Early years assessment

Students in kindergarten undertake an on-entry and on-exit assessment of their early reading and numeracy skills using the BASE program. NAPLAN

Students in years 3, 5, 7 and 9 in all ACT schools participate in the National Assessment Program-Literacy and Numeracy (NAPLAN). This program assesses skills in reading, writing, spelling, grammar and punctuation, and numeracy.

In this reporting period, 1.00 % of year 3 students and 0.00 % of year 5 students were exempt from testing based on nationally agreed criteria.

For reasons of statistical reliability, as well as to protect the privacy of students, results are not reported when the sample size is less than five.
