Summary of School Board activity

- The college went into lockdown at the end of session 1 and students began online learning and assessment.
- After 6 weeks of lockdown, students and teachers returned seamlessly to classes. Students reengaged effectively in classes with strong teacher support.
- Teachers' Professional Learning Communities focused on the quality of teaching with teachers working together to improve student outcomes.
- The College Review was completed successfully and new priorities will be developed to build on the three current priorities.
- The year 12 Formal went ahead at the Arboretum and was hugely successful.
- Year 12 Graduation was held in two sessions and feedback from our community was most positive for this new format.

School Context

Narrabundah College is a large and vibrant government co-educational college nestled in beautiful grounds located near the parliamentary triangle. The college has over 945 students in years 11 and 12 and offers a challenging curriculum in a caring environment to meet the needs of students in a globalised world. Narrabundah College has an international atmosphere with over 30% of our students born overseas.

The college's diverse curriculum includes nine languages offered at Beginning, Continuing and Advanced levels. In 2020 the languages offered were: Chinese, French, German, Hindi, Indonesian, Italian, Japanese, Korean and Spanish with over 500 students studying a second language.

In addition to the ACT Year 12 Certificate, the college offers the International Baccalaureate (IB) Diploma and the French Baccalauréat. Narrabundah College was the first school in Australasia to deliver the IB program and it has been delivering this curriculum successfully for over 40 years.

The college has maintained a tradition of success and offers a broad and academically rigorous curriculum that is carefully designed to enhance students' skills in research, critical thinking, communication and self-management in a focused and supportive environment. Study Hub was introduced in 2013: this resource continues to be accessed by large numbers of students to improve their study skills and support their learning.

Narrabundah College challenges national trends in Maths, Science and Languages in that we have significant numbers of students studying these subjects. In 2020 216 year 11 students and 171 year 12 students studied Specialist Options and/or Core Maths (the highest levels in Maths); 158 students studied Physics and 290 students studied Chemistry over the 2 years and a further 486 students studied Biology, Human Biology, Forestry and the Exercise Sciences. Over 500 students studied a second language.

In 2020, 55 year 11 students were offered places at ANU Extension and 46 year 12 students completed their chosen course of whom 6 topped their courses.

Further, in our environment, students are also encouraged to become significant contributors to society and take up challenges in areas such as: leadership, supporting charities, managing and improving the environment, debating, value adding to the local community, participating in sports and much more.

Narrabundah College recognises the special needs of students in the challenging senior secondary years and we continue to provide a safe, supportive and caring environment that fosters each student's personal growth. Our well-resourced Student Services Team advises students on course and careers counselling as well as monitoring and supporting students in their welfare, academic progress and student pathways planning during their two years at this college.

In 2020, the college continued to strengthen and promote the strong partnerships with our parents/carers and the community. For example: The Parent/Student/Teacher year 11 interviews are now embedded in our calendar to take place in December each year.

The college has an active P & C who have continued to improve the canteen environment for our students' use. The committee has maintained strong advocacy with the Education Directorate and the Minister of Education in the planning of the redevelopment of the college.

Staff Information

Teacher qualifications

All teachers at this school meet the professional requirements for teaching in an ACT public school. The ACT Teacher Quality Institute (TQI) specifies two main types of provision for teachers at different stages of their career, these are detailed below.

- Full registration is for teachers with experience working in a registered school in Australia or New Zealand who have been assessed as meeting the Proficient level of the Australian Professional Standards for Teachers.
- Provisional registration is for newly qualified teachers or teachers who do not have recent experience teaching in a school in Australia and New Zealand. Many teachers moving to Australia from another country apply for Provisional registration.

Workforce composition

Workforce composition for the current reporting period is provided in the following table. The data is taken from the school's verified August staffing report. For reporting purposes, it incorporates all school staff including preschools, staff absent for a period of less than four consecutive weeks and staff replacing staff absent for more than four consecutive weeks. It does not include casuals and staff absent for a period of four consecutive weeks or longer.

The Education Directorate is required to report Aboriginal and Torres Strait Islander staff figures. As of June of the reporting period, 135 Aboriginal and Torres Strait Islander staff members were employed across the Directorate.

School Review and Development

The ACT Education Directorate's Strategic Plan 2018-2021 provides the framework and strategic direction for School Improvement Plans (formerly School Strategic Plans). This is supported by the school performance and accountability framework 'People, Practice and Performance: School Improvement in Canberra Public Schools, A Framework for Performance and Accountability'. Annually, system and school level data are used alongside the National School Improvement Tool to support targeted school improvement, high standards in student learning, innovation and best practice in ACT public schools.

Our school was reviewed in 2020. A copy of the Report of Review can be found on our school website.

School Satisfaction

Schools use a range evidence to gain an understanding of the satisfaction levels of their parents and carers, staff and students. Annually in August/ September ACT schools undertake a survey to gain an understanding of school satisfaction at that time. This information is collected from staff, parents and from 2020 students from year 4 and above (previously year 5 and above) through an online survey.

Overall Satisfaction

In this period of reporting, 82% of parents and carers, 94% of staff, and 81% of students at this school indicated they were satisfied with the education provided by the school.

Included in the survey were 16 staff, 14 parent, and 12 student items which are described as the national opinion items. These items were approved by the then Standing Council on School Education and Early Childhood (SCSEEC) for use from 2015. The following tables show the percentage of parents and carers, students and staff who agreed with each of the national opinion items at this school.

Note: The overall response rate for parents and carers in ACT public schools was negatively impacted by COVID-19, dropping from 31% in 2019 to 23% in 2020.

A total of 72 staff responded to the survey. Please note that not all responders answered every question.
