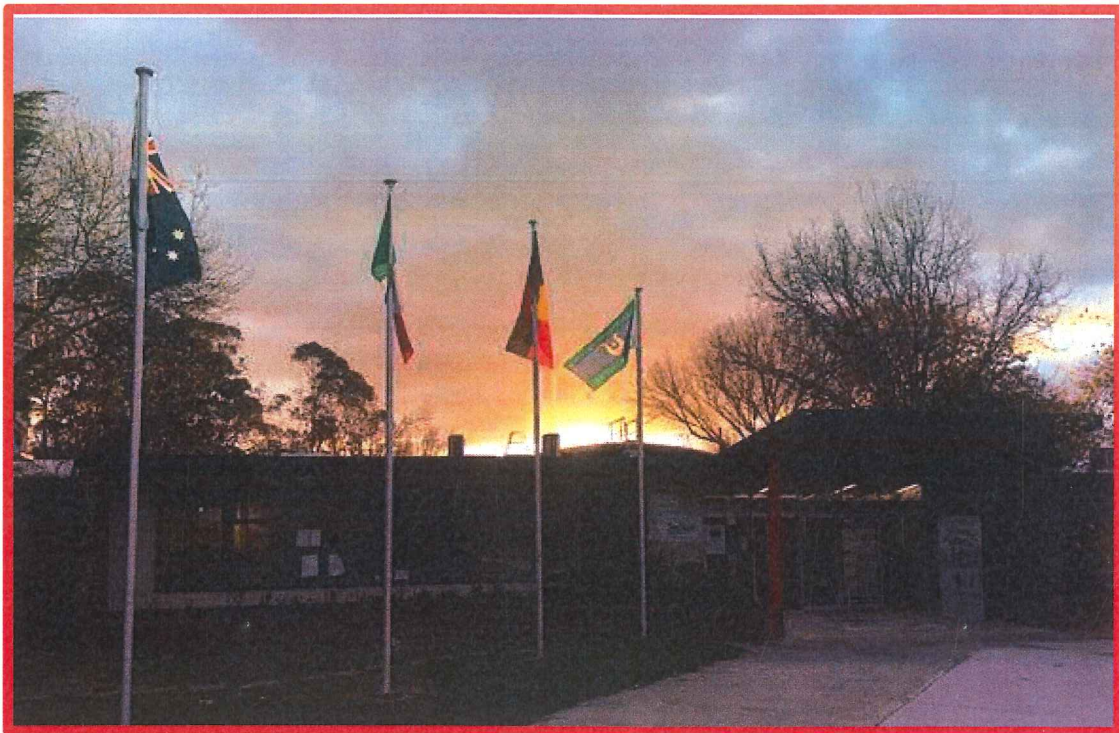

Summary of School Board activity

The Yarralumla Primary School Board is committed to assessing the needs of the school and to making recommendations on finances, facilities, buildings and equipment amongst other matters. It also supports the school to build long lasting relationships with community. In 2019 the Board accepted the recommendations provided through the School Review process and looks forward to working with staff, students, parents and the broader YPS community to implement the findings.

School Context

Yarralumla Primary School was established in 1957 in a beautiful setting on the southern shore of Lake Burley Griffin in Yarralumla. It is a small, family-friendly bilingual school catering for children aged 3 to 12. A variety of programs including a K – 6 specialised Italian language program, an English only stream, a pre-school program (4 year olds), a Montessori Stage one program (3 to 5 year olds) and a specialist Autism class for eligible students in years K-6.

Yarralumla Primary School aims to be a leading bilingual school in Australia, employing the Content Language Integrated Learning or CLIL methodology, to deliver 50% of the Australian curriculum through the Italian language. Gaining knowledge of the world through another language enables unique and valuable intercultural understandings necessary for being a true global citizen.

Yarralumla students receive quality instruction from skilled educators, a number of whom are native Italian speaking Australian citizens.

The school promotes the belief that all children have a right to develop, grow and learn in a community where each individual is valued and respected, and where each individual values, respects and contributes positively to others and the environment we all share. The school values diversity and fosters an inclusive learning environment, with a focus on sustainability. Specialist programs in Performing Arts are also delivered through a music tutor scheme, K-6 Performing Arts program, woodwind bands and a junior and senior choir.

Yarralumla has a strong community focus and a supportive parent body. The strength of the school lies in the close partnership between students, staff, parents and the wider community, which is highly valued by all.

Two after school care programs, a before school care program and a holiday program are available on site.

Aligned with the current Strategic Plan 2020 -2024, the school has embarked on a targeted program to improve literacy and numeracy in both languages.

Staff Information

Teacher qualifications

All teachers at this school meet the professional requirements for teaching in an ACT public school. The ACT Teacher Quality Institute (TQI) specifies two main types of provision for teachers at different stages of their career, these are detailed below.

- **Full registration** is for teachers with experience working in a registered school in Australia or New Zealand who have been assessed as meeting the Proficient level of the Australian Professional Standards for Teachers.
- **Provisional registration** is for newly qualified teachers or teachers who do not have recent experience teaching in a school in Australia and New Zealand. Many teachers moving to Australia from another country apply for Provisional registration.

Workforce composition

Workforce composition for the current reporting period is provided in the following table. The data is taken from the school's verified August staffing report. For reporting purposes, it incorporates all school staff including preschools, staff absent for a period of less than four consecutive weeks and staff replacing staff absent for more than four consecutive weeks. It does not include casuals and staff absent for a period of four consecutive weeks or longer.

The Education Directorate is required to report Aboriginal and Torres Strait Islander staff figures. As of June of the reporting period, 119 Aboriginal and/or Torres Strait Islander staff members were employed across the Directorate.

School Review and Development

The ACT Education Directorate's Strategic Plan 2018-2021 provides the framework and strategic direction for School Improvement Plans (formerly School Strategic Plans). This is supported by the school performance and accountability framework '*People, Practice and Performance: School Improvement in Canberra Public Schools, A Framework for Performance and Accountability*'. Annually, system and school level data are used alongside the National School Improvement Tool to support targeted school improvement, high standards in student learning, innovation and best practice in ACT public schools.

Prior to 2016 all ACT public schools participated in a four-year improvement cycle. In the fourth year schools underwent an External Validation process. In 2016 this changed to a five-year cycle with a School Review at the end.

Our school was reviewed in 2019. A copy of the Report of Review can be found on our school website.

School Satisfaction

Schools use a range of evidence to gain an understanding of the satisfaction levels of their parents and carers, staff and students. Annually in August/ September ACT schools undertake a survey to gain an understanding of school satisfaction at that time. This information is collected from staff, parents and students from year 5 and above through an online survey.

Overall Satisfaction

In this period of reporting, 77% of surveyed parents and carers, 93% of surveyed staff, and 87% of surveyed students at this school indicated they were satisfied with the education provided by the school.

Included in the survey were 16 staff, 14 parent, and 12 student items which are described as the national opinion items. These items were approved by the then Standing Council on School Education and Early Childhood (SCSEEC) for use from 2015. The following tables show the percentage of parents and carers, students and staff who agreed with each of the national opinion items at this school.

A total of 29 staff responded to the survey. Please note that not all responders answered every question.

Performance in Literacy and Numeracy

Early years assessment

Students in kindergarten undertake an on-entry and on-exit assessment of their early reading and numeracy skills using the Performance Indicators in Primary Schools (PIPS) program. Student results are reported against five performance bands at the end of semester 1 and 2. Below are the results for this school for the current reporting period.

NAPLAN

Students in years 3, 5, 7 and 9 in all ACT schools participate in the National Assessment Program-Literacy and Numeracy (NAPLAN). This program assesses skills in reading, writing, spelling, grammar and punctuation, and numeracy.

In this reporting period, 2.10 % of year 3 students and 4.20 % of year 5 students were exempt from testing based on nationally agreed criteria.

For reasons of statistical reliability, as well as to protect the privacy of students, results are not reported when the sample size is less than five.

The following table shows the mean scores achieved by students at this school compared to all other ACT public schools for this reporting period.

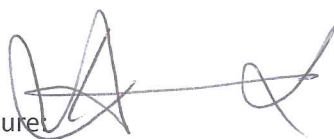
