# School Improvement Plan 2020-2024

# The purpose of school improvement planning

This plan establishes a strong improvement agenda to be driven by school leaders over the next five years. It was informed by the Directorate's Strategic Plan and system-level and school-based analysis of multiple sources of evidence including our School Review findings. Analysis of these multiple sources of evidence is supported by an annual provision to each school of a data summary as a key enabler of our improvement planning and implementation.

Each school undertakes a school review as an integral component of in its five-year improvement planning cycle. The reviews are an important part of how the Directorate supports and monitors school improvement. Reviews provide schools with quality and independent feedback, tailored to the school's context. Each school is reviewed at least every five years, providing valuable opportunities for self-reflection, planning and improvement. The school improvement planning process is below. This representation is used in the footer of all school-based improvement documents to indicate the stage of planning or implementation.

# Our improvement priorities

**Priority 1:** Increase growth in student performance in writing across all year levels.

#### Vision for Change

- Students demonstrate excitement and joy about writing and see themselves as writers
- Students can write for a sustained period of time.
- Students write for authentic purposes and audiences.
- Students use author words as inspiration for their own writing.
- Students' talk about their writing using metalanguage.
- Students have high expectations about themselves as writers

# Targets/Measures to be achieved by 2024

#### Student learning data

**Target or measure:** to increase the percentage of year 5 students in the top two bands of writing to 19% or more. The target was set by averaging the top 2 bands or writing for similar schools (26%) 2015 - 2019.

Source: NAPLAN percentage in bands available through SCOUT.

**Starting point:** baseline data of 14% points was determined by averaging the percentage of students in the top 2 bands of writing for the school over 2015 – 2019.

**Target or measure:** to decrease the percentage of year 5 students in the bottom two bands of writing to 13% or less. (the target was set by averaging the bottom 2 bands or writing for similar schools (9%) 2015 - 2019).

**Starting point:** baseline data of 18% points was determined by averaging the percentage of students in the bottom 2 bands of writing for the school over 2015 - 2019.

#### Perception data

**Target or measure:** to improve the percentage of students who strongly agree and agree that 'teachers give useful feedback' to 80%

**Source:** School Satisfaction Survey (student)

**Starting point:** baseline data of 76.33% who strongly agreed and agreed was determined by averaging the percentage 2016 - 2018.

**Target or measure:** to improve results in the teacher survey around the use of conferencing to improve writing results. Target to be determined after baseline data is collected.

**Source:** Google teacher survey of conferencing practices **Starting point:** baseline to be determined in term 1, 2020.

#### Vision for Change

- Students have positive attitudes and feelings towards mathematics.
- Students' talk about mathematics to assist them to develop metacognitive skills
- Students engage with mathematics through open-ended, collaborative tasks that engage them in **problem solving** in a real-world context.
- Students learn by being explicitly taught mathematical concepts, progressing from concrete to abstract representations.
- Flexible and efficient mental computation strategies are developed.

# Targets/Measures to be achieved by 2024

### Student learning data

**Target or measure:** 56% or more of our year 5 students will be achieving at or above expected growth in numeracy. The target was set by averaging the percentage of students achieving at or above expected growth in similar schools over 2015 - 2019 (63%).

Source: NAPLAN growth data available through SCOUT.

**Starting point:** baseline data of 51% was determined by averaging percentages of students achieving at or above expected growth over the previous five years at Arawang Primary (2015 - 2019).

#### Perception data

**Target or measure:** to improve the percentage of students who strongly agree and agree that 'teachers give useful feedback' to 80%

Source: School Satisfaction Survey (student)

**Starting point:** baseline data of 76.33% who strongly agreed and agreed was determined by averaging the percentage 2016 – 2018.

**Target or measure:** to improve positive attitudes to mathematics from 43% in 2019 to 50% or more by 2024. The target was set using a school-based survey of students from years 2-6.

Source: Arawang student survey of attitudes and feelings towards mathematics.

Starting point: 43% baseline determined in term 4, 2019.
