





School Context

Neville Bonner Primary School's Strategic Plan (2013-2016) describes the strategic direction for the school's initial four years. The four priorities of this inaugural Strategic Plan focus on establishing the school as a respectful and contemporary learning community. They embody a deep commitment to both high expectations and authentic community partnerships.

Strategic Priority 1: Develop a contemporary educational environment to ensure successful learning for all students within a respectful relationships framework

Performance Measures

- Improvement in the proportion of students in NAPLAN proficiency bands in Year 3 and 5
- Improvement in the proportion of students value added progression in PIPS data
- Value added progression for every student (P-Yr 6) in school based assessment tools: English.

Key Improvement Strategies

- Implement an inclusive and rigorous curriculum
- Enact contemporary teaching and learning practices consistent with the Australian Curriculum and current research
- Establish the Aboriginal and Torres Strait Islander priority of the Australian Curriculum as a central lens of the school's curriculum
- Develop and foster parent/carer partnerships in the education of their children
- Develop the school as a professional learning community, supported by an effective leadership strategy
- Foster student voice inclusively across the practices of the school
