School Improvement Plan 2022-2026

The purpose of school improvement planning

This plan establishes a strong improvement agenda to be driven by school leaders over the next five years. It was informed by the Directorate's Strategic Plan and system-level and school-based analysis of multiple sources of evidence. Analysis of these multiple sources of evidence is supported by an annual provision to each school of a data summary as a key enabler of our improvement planning and implementation.

Each school participates in School Review as an integral component of in its five-year improvement planning cycle. Review findings support annual improvement planning (Action Plan) and are an important component of Directorate monitoring and support of school improvement. Reviews provide schools with quality and independent feedback, tailored to the school's context. Each school is reviewed at least every five years, providing valuable opportunities for self-reflection, planning and improvement. The school improvement planning process is below. This representation is used in the footer of all school-based improvement documents to indicate the stage of planning or implementation.

Our improvement priorities

Priority 1: Improve student performance in reading across K-6

At the end of our 5 year plan:

- Students will experience consistent high-quality literacy teaching practice across
 Preschool to Year 6 and as they progress through their journey of education at Amaroo
 School.
- Students will access, understand, analyse, and evaluate information, make meaning, express thoughts and emotions, present ideas and opinions, interact with others and participate in activities at school and in their lives beyond school as defined by the Australian Curriculum.

Targets/Measures to be achieved by 2026

Student learning data

Target or measure: To increase the average for Year 3 Reading to 451 mean scaled scores or more. The target was set by averaging the Year 3 Reading mean scale scores for similar schools over 2018 – 2021.

Source: NAPLAN data available through SCOUT

Starting point: Baseline data of 433 mean scaled scores was determined by averaging the mean scaled scores for Year 3 Reading over 2018 – 2021.

Target or measure: To increase the percentage of students achieving expected/high growth in Reading in PIPS/BASE to 78% or more. The target was set by averaging the two highest percentages of students achieving expected/high growth over 2016-2019.

Source: PIPS/BASE data available through Analytics and Evaluation (PIPS assessment was replaced by BASE assessment in 2020).

Starting Point: Baseline data of 74% was determined by averaging the percentage of students achieving expected/high growth in PIPS/BASE Reading for the school over 2016-2019.

Perception data

Target or measure: Increase to meet all school average for our Year 4-6 students agree or strongly agree that *Teachers give useful feedback*. The target was set by averaging the percentages of agree or strongly agree over 2017-2020 for ACT 7-10 schools and aligns with improvement cycle in writing.

Starting Point: Baseline data of -4.7% below all school average for our Year 4-6 students agree or strongly agree that *Teachers give useful feedback*. This was determined by averaging the school data for Year 4-6 students over 2017-2020. School program and process data

School program and process data

Target or measure: To decrease the percentage of students in the bottom three stanines of the PAT-Comprehension assessment to 16% of Year 2 students and 16% of Year 6 students.

Source: ACER Online Assessment and Reporting System – PAT comprehension 2018-2020 **Starting point:** Baseline data of 20% of students for both Year 2 and Year 6 represented in the bottom three stanines was determined through averaging the percentage of students in this range over 2018-2020.

Priority 2:

Improve student performance in writing across years 7-10

At the end of our 5 year plan:

- We will improve critical and creative thinking at Amaroo School through building student capacity to inquire, explore, organise information, and communicate ideas in writing
- Writing strategies will be grounded in disciplinary literacy which highlights vocabulary, ideas, concepts, and themes unique to each subject's language
- Students will experience consistent research based displinary literacy strategies across all faculties from Years 7 to 10 to improve student writing outcomes.

Targets to be achieved by 2026

Student learning data

Target or measure: To decrease the percentage of Year 9 students in the bottom two bands of Writing to 26% (approx. 53 students) or less. The target was set by averaging the percentage of students in the bottom two bands of Writing for similar schools over 2017-2021.

Starting Point: Baseline data of 38% (approx. 76 students) was determined by averaging the percentage of students in the bottom two bands of Writing for the school over 2017 -2021.

Perception data

Target or measure: Increase to **5%** above all school average for our Year 7-10 students agree or strongly agree that *Teachers give useful feedback*. The target was set by averaging the percentages of agree or strongly agree over 2017-2020 for ACT 7-10 schools and aligns with improvement cycle in writing.

Starting Point: Baseline data of 3% above all school average for our Year 7-10 students agree or strongly agree that *Teachers give useful feedback*. This was determined by averaging the school data for Year 7-10 students over 2017-2020.
