Summary of School Board activity

Amaroo School continues to meet the needs of its growing community. Our focus on excellence, inclusion and helping students reach their potential will see our school community continue to thrive.

Meeting seven times during 2021, the working relationship of the Board, Executive, staff and students was highly collaborative, despite the ongoing challenges that a second year of COVID-19 presented. The Board discussed a broad range of issues relating to teaching and learning within the school, improvements to the school environment, management of the school budget, and changes in education policies relevant to the operation of the school. There was a particular focus on the well-being of staff and students.

Throughout these unprecedented times, school operations have continued as normal and in semester 2 2021, the school board was presented with the final copy of the new Strategic Action Plan, which was developed following School Review in Term 2 2021.

School Context

Amaroo School is located in the Gungahlin region and is the largest ACT public school. Our student enrolment in February 2021 was 1,927 from Preschool to Year 10. Our student profile represents a highly diverse and multicultural background. We provide for over 200 students with diagnosed special needs including six learning support classrooms for students with autism (LSUAs). We also boast a high Defence Force population with approximately 150 students from Australian Defence Force families. We highly value our diversity as it represents the unique nature of the people in our school.

Each year we have an increased student population enrol into our year 7 from Neville Bonner and Margaret Hendry Primary Schools and we expect the numbers to steadily increase each year.

The values that guide our work are: Excellence in all that we do and expect; and Inclusion of all members of our school community through respect tolerance and recognition of difference. We aim to maximise learning for all students supporting and challenging them to develop their talents to their full potential. We promote a culture of belonging by collectively contributing to a safe and welcoming environment for all.

Student attendance

Staff Information

Teacher qualifications

All teachers at this school meet the professional requirements for teaching in an ACT public school. The ACT Teacher Quality Institute (TQI) specifies two main types of provision for teachers at different stages of their career, these are detailed below.

- Full registration is for teachers with experience working in a registered school in Australia or New Zealand who have been assessed as meeting the Proficient level of the Australian Professional Standards for Teachers.
- Provisional registration is for newly qualified teachers or teachers who do not have recent
 experience teaching in a school in Australia and New Zealand. Many teachers moving to
 Australia from another country apply for Provisional registration.

Workforce composition

Workforce composition for the current reporting period is provided in the following table. The data is taken from the school's verified August staffing report. For reporting purposes, it incorporates all school staff including preschools, staff absent for a period of less than four consecutive weeks and staff replacing staff absent for more than four consecutive weeks. It does not include casuals and staff absent for a period of four consecutive weeks or longer.

The Education Directorate is required to report Aboriginal and Torres Strait Islander staff figures. As of June of the reporting period, 135 Aboriginal and/or Torres Strait Islander staff members were employed across the Directorate.

School Review and Development

The ACT Education Directorate's Strategic Plan 2018-2021 provides the framework and strategic direction for School Improvement Plans (formerly School Strategic Plans). This is supported by the school performance and accountability framework 'People, Practice and Performance: School Improvement in Canberra Public Schools, A Framework for Performance and Accountability'. Annually, system and school level data are used alongside the National School Improvement Tool to support targeted school improvement, high standards in student learning, innovation and best practice in ACT public schools.

Our school was reviewed in 2021. A copy of the Report of Review can be found on our school website.

School Satisfaction

Schools use a range evidence to gain an understanding of the satisfaction levels of their parents and carers, staff and students. Annually in August/ September ACT schools undertake a survey to gain an understanding of school satisfaction at that time. This information is collected from staff, parents and from 2020 students from year 4 and above (previously year 5 and above) through an online survey.

Overall Satisfaction

In this period of reporting, 81.5% of parents and carers, 92.8% of staff, and 69.8% of students at this school indicated they were satisfied with the education provided by the school.

Included in the survey were 8 staff, 9 parent, and 10 student items which are described as the national opinion items. These items were approved by the then Standing Council on School Education and Early Childhood (SCSEEC) for use from 2015. The following tables show the percentage of parents and carers, students and staff who agreed with each of the national opinion items at this school.

Due to the impacts of the COVID-19 pandemic, the survey was taken in November, rather than in August as has been done in previous years. This was just after the majority of students and staff returned to school-based learning after a period of around 3 months of remote learning. A number of questions were removed from previous years' to shorten the time required by community members to complete the survey.

A total of 97 staff responded to the survey. Please note that not all responders answered every question.

Performance in Literacy and Numeracy

Early years assessment

Students in kindergarten undertake an on-entry and on-exit assessment of their early reading and numeracy skills using the BASE program. Student results are reported against five performance bands at the end of semester 1 and 2. Below are the results for this school for the current reporting period.

NAPLAN

Students in years 3, 5, 7 and 9 in all ACT schools participate in the National Assessment Program-Literacy and Numeracy (NAPLAN). This program assesses skills in reading, writing, spelling, grammar and punctuation, and numeracy.

In this reporting period, 2.56 % of year 3 students, 0.65 % of year 5 students, 0.83 % of year 7 students and 1.27 % of year 9 students were exempt from testing based on nationally agreed criteria.

For reasons of statistical reliability, as well as to protect the privacy of students, results are not reported when the sample size is less than five.
